

# POULTRY DEPARTMENT

## Dept. 960

1. Department opens at 4:00 p.m. for check-in on Thursday, October 9, 2025. All birds must be received no later than 5:30 p.m. Show starts at 6:00pm.
2. **Exhibitors will be required to bring their own cage for birds. THERE ARE NO COOPS ON GROUNDS TO HOUSE POULTRY.**
3. **Each exhibitor will be required to pay an entry fee of \$5.00 per animal. Make checks payable to Piedmont Interstate Fair. You can also email your form to [piedmontinterstatefair@att.net](mailto:piedmontinterstatefair@att.net) and then request a link to pay via card. 3% convenience fee will apply.**
4. **Exhibitors will need to enter through the cattle gate to check in with show animal and up to 4 (four) guests. Admission will need to be paid for all others. Please be aware that only one vehicle and trailer will be allowed to park behind the barn.**
5. The Piedmont Interstate Fair Show Manager reserves the right to make decisions concerning or changing rules, regulations, and/or health requirements.
6. Any animal exhibiting any significant visible symptoms of disease or sickness will not be allowed to be unloaded from the vehicle or remain on the fair/show grounds. **All birds must have a current negative NPIP test. Participants are to present their copy of the paper form showing proof of NPIP testing at the check in table. The birds wing band number will be cross checked with the form to determine eligibility to be entered in the show.**
7. The Piedmont Interstate Fair will not be responsible for any loss that may occur, but every precaution will be taken to prevent any loss.
8. The decision of the judges must be taken as final.
9. During the exhibition, no birds entered may be removed, except by order of the superintendent. Birds must remain in place until after show. Any specimen removed beforehand will forfeit all premiums.
10. Any matter not covered by the above rules, or any complaints will be submitted to the Executive Director who shall have sole and final jurisdiction.
11. Only pullets and hens may be shown.
12. **All poultry should be removed after the show. The Piedmont Interstate Fair Association will not be responsible for any animals left.**
13. Poultry premiums will be mailed to exhibitors using address provided on entry form, after the Fair. The following premiums will be paid when classes are filled:
